Course Description:

This course provides a chronological and historical survey examining painting, sculpture, and architecture of Western cultures beginning with prehistory to the fifteenth century. This course will focus on significant developments in the visual arts and their connection to and reflection of the political, religious and social influences of the time. In addition, the course will consider how art can be interpreted through a Christian worldview.

Expected Learning Outcomes

 cognizant of how the visual arts from the past are revealed in the contemporary world. Assessment: Weekly
 connection assignments and final project

EVALUATION

<u>Class Quizzes</u> 20 marks

Quizzes will be given each week. They will be based on the readings and lectures as well as in-class projects for that class. No makeup quizzes will be given. Each quiz is worth 2% of final grade.

Weekly Connection Assignments 20 marks

Students will be required to select and include the image and details (title, date, artist, medium and collection) of one work of art from each lecture and one other work of art (student's choice) from a different time period and **briefly** describe, incorporating the relevant appropriate visual language, the connection between these works. These assignments are due at the beginning of the class following the last lecture. Images are to be in colour. Students can submit 10 assignments. **Hard copy at the beginning of each class.** Each assignment is worth 2% of final grade

Formal Analysis 15 marks

Students will be required to visit an art gallery and write a formal analysis of a work of art (student's choice) on display. A guideline will be provided for the students. **Due Date: November 28, 2016** (hard copy only at beginning of class)

Research Essay 25 marks

Students are required to submit one research paper, with a title page, 12–point Times New Roman font, double-spaced with 1" margins and 2000 (minimum) to 2500 (maximum) words. Pages must be numbered and word count is to be included.

- Topics will be the student's choice and each topic must include at least two art works and no more than three
 artworks. Students will be required to submit 5 possible topics/subjects by October 3 at the beginning of class
 only. Topic is be approved by instructor.
 - a. Topic choices are to be typed and handed in at the beginning of class: October 3, 2016
 - b. Students <u>will be required</u> to meet with the instructor on Monday afternoon **October 3** or Tuesday, **October 4** in morning or afternoon before 3:00, for topic discussion and approval..

- 2. **Bibliographic sources** (minimum 5-8) can be from print (books and periodicals but *no* encyclopedias) and non-print (on-line journals and/or scholarly websites) as well as photographs, photocopies, or scanned images of the art works discussed in the paper and all will need to be documented in MLA style.
 - Proposed Bibliography formatted correctly in MLA due: October 17, 2016 at the beginning of class.
 Hard copy.
- 3. Introductory paragraph and a sample paragraph typed and documented (MLA) due: October 24, 2016 at the beginning of class. Hard copy
- 4. Final Paper due: November 7, 2016 at the beginning of class (hard copy only).

Final Project/Presentation

20 marks

- 1. This project will be an extension of the connection exercises that students are required to do weekly, their formal analysis and a continuation of their research essay. Students will use the subject of their essay research and connect it to an art piece (painting, sculpture or architecture) from their contemporary lives.
- 2. Date of Presentation: December 19, 2016. All students are required to be present.

Attendance:

- 1. Students are expected to attend and participate in all classes. Since the course will be covering a considerable content during the term and in order to be prepared for each class, students are advised review the slide list and the chapter(s) being cover prior to each class. Slide lists will be posted on Moodle prior to each class.
- 2. There is a quiz each class and no make up quizzes will be given.
- 3. The class will be a combination of lecture, small group work, quizzes and the possible addition of films and/or a guest lecture.

Communication
