COURSE DESCRIPTION

A chronological and historical survey examining painting, sculpture and architecture beginning with prehistory to the 15th century of Western cultures. This course will focus on significant developments in the visual arts and their connection to and reflection of the political, religious and social influences at the time. In addition the course will consider how art can be referenced through a Christian worldview

EXPECTED LEARNING OUTCOMES

- 1. To see beyond the mere appearance and understand how the arts reflect worldviews including Christian and be cognizant of how the visual arts from the past are revealed in the contemporary world. Assessment: Weekly connection assignments and final project
- 2. To acquire an understanding of the language of the visual arts and to be able to use it in both a formal and research analysis of the works of art included during these time periods. Assessment: Weekly connection
- 3. To see beyond the mere appearance and understand how the arts reflect worldviews including Christian and be cognizant of how the visual arts from the past are revealed in the contemporary world. Assessment: Weekly connection assignments and final project

4. To acquire an understanding of the language of the visual arts and to be able to use it in both a formal and research analysis of the works of art included during these time periods. Assessment: Weekly connection assignments, formal analysis paper, research essay and final project.

REQUIREMENTS:

Class Quizzes 20 marks

Quizzes will be given each week. They will be based on the readings and lectures as well as in-class projects for that class. Students need to be present for the lecture in order to take the quiz. No makeup quizzes will be given. Each quiz is worth 2% of final grade.

Weekly Connection Assignments

20 marks

Students will be required to select and include the image and details (title, date, artist, medium and collection) of one work of art from each lecture and one other work of art (student's choice) from a *different* time period and *briefly* describe, incorporating the relevant appropriate visual language, the connection between these works. These assignments are due at the beginning of the class following the last lecture. Images are to be in colour. Students can submit 10 assignments in hard copy at the beginning of each class. Each assignment is worth 2% of final grade

Formal Analysis

15 marks

Students will be required to visit an art gallery and write a formal analysis of a work of art (student's choice) on display. A guideline (Moodle) will be provided for the students. **Due Date: October 2, 1017** in **hard copy only at beginning of class. Late papers will not be accepted.**

Research Essay

25 marks

Students are required to submit one research paper, with a title page, 12–point Times New Roman font, double-spaced with 1" margins and 2000 (minimum) to 2500 (maximum) words. Pages must be numbered and word count is to be included.

- 1. Topics will be the student's choice and each topic must include at least two art works and no more than three artworks. Students will be required to submit 5 possible topics/subjects by October 16 at the beginning of class only. Topic is be approved by instructor.
 - a. Topic choices are to be typed and handed in at the beginning of class: October 16, 2017
 - b. Students will be required to meet with the instructor on Monday afternoon October 16 or Tuesday, October 17 in morning or afternoon before 3:00, for topic discussion and approval. Sign up sheet will be made available.
- 2. **Bibliographic sources** (minimum 5-8) can be from print (books and periodicals but *no* encyclopedias) and non-print (on-line journals and/or scholarly websites) as well as photographs, photocopies, or scanned images of the art works discussed in the paper and all will need to be documented in MLA style.
 - Proposed Bibliography formatted correctly in MLA and thesis due: at the beginning of class, hard copy only October 30, 2017
- 3. **Essay due: November 13, 2017** at the beginning of class (hard copy only). Late papers will not be accepted.

Final Project/Presentation

20 marks

- This project will be an extension of the connection exercises that students are required to do weekly, their
 formal analysis and a continuation of their research essay. Students will use the subject of their essay research
 and connect it to an art piece (painting, sculpture or architecture) from their contemporary lives. (See Moodle
 for guideline)
- 2. **Date of Presentation**: Monday, December 18, 2017 from 9-12 am in room G-2195. All students are required to be present.
- 3. It is the student's responsibility to resolve any exam conflicts by Monday, October 23, 2017.

Attendance:

- Students are expected to attend and participate in all classes. Since the course will be covering a considerable
 content during the term and in order to be prepared for each class, students are advised review the slide list and
 the chapter(s) being covered prior to each class. Slide lists will be posted on Moodle prior to each class.
- 2. There is a quiz each class and no make up quizzes will be given.
- 3. The class will be a combination of lecture, small group work, quizzes and the possible addition of films and/or a guest lecture.
