Course Description This course provides a chronological and historical survey examining painting, sculpture, and architecture of Western cultures beginning with the Renaissance to the present day. This course will focus on significant developments in the visual arts and their connection to and reflection of the political, religious, and social influences of the time. In addition, the course will consider how art can be understood through a Christian worldview.

Expected Learning Outcomes

The arts provide a compelling framework through which history and life can be understood in a holistic way. Given this, the following learning outcomes are important to provide the ways and means of comprehending the value of art.

- 1. To develop an understanding of the major periods of painting, sculpture and architecture in their historical contexts and their function and value from the prehistory to 15th Century. **Assessment:** Weekly quizzes based on reading, lectures and in class projects
- 2. To be informed of the materials and techniques used as well as stylistic, symbolic and iconographic influences of the visual arts. **Assessment:** Weekly readings, quizzes, in class projects as well as connection assignments
- 3. To see beyond the mere appearance and understand how the arts reflect worldviews including Christian and be cognizant of how the visual arts from the past are revealed in the contemporary world. **Assessment:** Weekly connection assignments and final project

4. To acquire an understanding of the language of the visual arts and to be able to use it in both a formal and research analysis of the works of art included during these time periods. **Assessment:** Weekly connection assignments, formal analysis paper, research essay and final project.

REQUIREMENTS FOR EVALUATION:

Class Quizzes 20 marks

Quizzes based on the readings and lectures as well as in class project will be given each week. <u>No makeup quizzes</u> will be given. Each quiz is worth 2% of final grade.

Weekly Connection Assignments 20 marks

Students will be required to select and include the images and details (title, date, artist, medium and collection) of one work of art from each lecture and one other work of art (student's choice) from a <u>different time period</u> and briefly describe, incorporating the appropriate visual language, the connection between these works. These assignments are due weekly in hardcopy. Students can submit up to 10 assignments, each of which must be identified by number and

title. (*For example: # 1. Early Renaissance in 15th C Italy*). Each assignment is worth 2% of final grade and is due at the beginning of each class in hardcopy. (*Guideline is posted on Moodle*).

Formal Analysis

15 marks

Students will be required to <u>visit an art gallery</u> and write a formal analysis of a work of art on display. A guideline will be provided for the students. (*Guideline is posted on Moodle*). Due: February 13, 2017

Research Essay

25 marks

Students are required to submit one research paper, with a title page, 12–point Times New Roman font, double-spaced with 1" margins and 2000 (minimum) to 2500 words (maximum). Pages must be numbered and word count is to be included. (*Rubric is posted on Moodle*).

- 1. Topics will be the student's choice (from this term's study) and must be approved by instructor. (The topic will need to include 2 or 3 art works to be discussed in the paper).
- Students will be required to bring 5 possible <u>specific</u> topics/subjects to be handed in at the beginning of class.
 February 6, 2017. Students will meet with Instructor Monday (6th) afternoon and or Tuesday, (7th) morning for approval.
- 3. Thesis statement of topic due February 14, 2017. Please send to instructor via email.
- 4. Works Cited sources can be from print (books and periodicals but no encyclopedias) and non-print (on-line journals and or scholarly websites) as well as photographs, photocopies, or scanned images of the art works discussed in the paper and all will need to be documented in MLA Parenthetical Style.
 - a. Proposed Works Cited page formatted correctly in MLA due: February 27, 2017.
- 5. Final Paper due: March 20, 2017 at the beginning of class. Hard copy.
 - a. Students are required to submit one research paper, 12–pt. Times New Roman font, double-spaced with 1" margins and 2000 2500 words. Word count is to be included. Marks will be deducted if the above requirements are not met. *See Rubric on Moodle.*

Final Project/Presentation

20 marks

This project will be an extension of the connection exercises that students are required to do weekly, their formal analysis and a continuation of their research essay. Students will use the subject of their essay research and connect it to an art piece (painting, sculpture or architecture) from their contemporary lives. Students are expected to present their project on the Final Examination date as posted on the syllabus and are required to make appropriate adjustments if there is a conflict. (Guideline is posted on Moodle).

Attendance:

Students are expected to attend on time and participate in all classes. Since the course will be covering a considerable content during the term and in order to be prepared for each class, students are encouraged to review the material prior to each class. Slide lists will be posted on Moodle prior to each class. The class will be a combination of lecture, small group work, quizzes and the possible addition of films and/or a guest lecture. *Please note students who are late for class and miss the lecture, cannot participate in the quiz. Missed class quizzes cannot be made up.

Communication

Appeal of Grade

An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
