Course Description

This is a semester long independent research project. The course provides the student with the opportunity to integrate the breadth of knowledge gained in prerequisite courses and apply it towards a hands-on chemistry experience while doing an independent research project

Expected Learning Outcomes

At the end of the course, students should have acquired the following skills:

- 1. Students will integrate skills and knowledge from core chemistry courses and apply them to an independent research
- 2. Students will develop a basic understanding of scientific literacy in the specific area of their research

- 3. In the project students will build hypothesis and plan experiments. They will then execute on this plan to design and perform experiments
- 4. Students will learn to interpret the results and learn to rationalize them in the context of their hypothesis and communicate this in a scientific way in the form of a written paper or presentations.

Textbooks

No textbook required.

Topic: specific research papers will be used.

Course Schedule:

Students will choose a research topic of choice, perform a literature search and literature summary before writing up a research proposal. Pilot experiments will be completed by the student. Upon completion of the project, a research report needs to be submitted. Results will be presented at the Ambrose Research Conference.

Evaluation Methods:

Research Proposal: 5% (January 15)

Research Performance Evaluation: 20%

This is based on level of active participation in research activities. This includes an evaluation of achieving 10 hrs/week in the laboratory over the 8 months term in a regular semester and the ability to integrate the skills learned.

Research Progress Presentation: 20%

Each student will give a 10-Minute oral presentation outlining the research objectives and progress to date on a biweekly basis.

Research Report: 45%

Each student will submit a formal, written report by the due date.

The research report should contain the following elements:

- Abstract
- Introduction
- Experimental Section
- Results and Discussion
- Conclusion

Grade for Oral Presentation: 10%

Each student will present a 15 minute formal oral presentation. Your supervisor will provide a grade based on the quality and your level of knowledge demonstrated during this presentation.

Plagiarism:

Plagiarism is a very serious academic offence that involves presenting work in a course as if it were the result of one's own study and investigation when, in fact, it is the work of someone else. Plagiarism takes place when:

- an essay or other work is copied from another source, including your peer's work, and submitted as one's own
- parts of a work, including words, ideas, images or data, are taken from a source without acknowledgement of the originator
- work presented for one course is also submitted for another course without prior agreement of the instructors involved
- another person prepares the work that is submitted as one's own
- substantial editorial or compositional assistance from another person is received on work that is submitted as one's own

Communication

All students have received an Ambrose e-mail account upon registration. Students will not receive a tuition refund for courses from which they withdraw after the Registration Revision period. A grade of "W" will appear on their transcript.

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.

Exam Scheduling

Students, who find a conflict in their exam schedule must submit a Revised Examination Request form to the Registrar's Office by the deadline date; please consult the List of Important Dates. Requests will be considered for the following reasons only: 1) the scheduled final examination slot conflicts with another exam; 2) the student has three final exams within three consecutive exam time blocks; 3) the scheduled final exam slot conflicts with an exam at another institution; 4) extenuating circumstances. Travel is not considered a valid excuse for re-scheduling or missing a final exam.

Electronic Etiquette

An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
