**Textbook:**

Outbreak Investigations around the World: Case studies in Infectious Disease Field Epidemiology; Mark S. Dworkin; Jones and Bartlett; 2009.

**Course Description:**

Through case study work, textbook reading, and personal research, the student will learn about the spread and containment of disease, the role of epidemiology, and about the biology of several pathogens.

**Expected Learning Outcomes:**

1. Through case study work, textbook reading, and personal research, the student will learn about the spread and containment of disease, the role of epidemiology, and about the biology of several pathogens.
2. Students will learn how to critically examine case studies.
3. Students will become proficient at literature searches and research.
4. Students will develop skills in paper –writing.

**Course Schedule:**

This is a directed study course. There is no regularly scheduled class. Regular meetings with the instructor are arranged with individual students.

**Requirements:**

**Mark Distribution** : 11 Case Study Reports – 7% each; 77% total  
Final In-depth Case Study report - 23%

Students will be responsible for reading all case studies in the book. From these 19 case studies, you will choose 12 to write up in essay format. Eleven of the 12 case reports should be quite brief (4-6 pages), providing an overview of the chapter by summarizing the outbreak and its resolution, while highlighting the investigative process that took place. You are also expected to briefly describe the pathogen, its morphology, ecological niche and reproduction, infection and spread of disease, clinical manifestations (disease symptoms) and pathogenicity, virulence, detection and diagnosis, treatment, prevention and other relevant information.

The twelfth report is to be a more in-depth term paper describing the disease outbreak and resolution, a step-by-step account of the investigative process involved, pathogen and disease descriptions including the most recent research data and conclusions of the pathogen. This paper is expected to be between 15 to 20 pages (double-spaced text, not including reference list, tables and/or illustrations).

Electronic submissions preferred. Four short reports are due before Wednesday, September 30, four short reports are due before Friday, October 20, while the remainder three short reports are due by Friday, November 27. The in-depth term paper is due by Tuesday, December 22. You may submit more than the required four or three short report, or the term paper earlier any time prior to their due dates. Late submissions are not accepted unless written request for extension is received prior to a deadline.

## Policies:

### Communication

All students have received an Ambrose e-mail account upon registration. It is the student's responsibility to check this account regularly as the Ambrose email system will be the professor's instrument for notifying students of important matters (cancelled class sessions, extensions, requested appointments, etc.) between class sessions. If students do not wish to use their Ambrose accounts, they will need to forward all messages from the Ambrose account to another personal account.

### Registration

During the **Registration Revision Period** students may enter a course without permission, change the designation of any class from credit to audit and /or voluntary withdraw from a course without financial or academic penalty or record. Courses should be added or dropped on the student portal by the deadline date; please consult the List of Important Dates. After that date, the original status remains and the student is responsible for related fees.

Students intending to withdraw from a course after the Registration Revision Period must apply to the Office of the Registrar by submitting a "Request to Withdraw from a Course" form or by sending an email to the Registrar's Office by the **Withdrawal Deadline**; please consult the List of Important Dates on the my.ambrose.edu website. Students will not receive a tuition refund for courses from which they withdraw after the Registration Revision period. A grade of "W" will appear on their transcript.

### Exam Scheduling

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.

Students, who find a conflict in their exam schedule must submit a Revised Examination Request form to the Registrar's Office by the deadline date; please consult the List of Important Dates. Requests will be considered for the following reasons only: 1) the scheduled final examination slot conflicts with another exam; 2) the student has three final exams within three consecutive exam time blocks; 3) the scheduled final exam slot conflicts with an exam at another institution; 4) extenuating circumstances. Travel is not considered a valid excuse for re-scheduling or missing a final exam.

### Electronic Etiquette

### Extensions

Although extensions to coursework in the semester are at the discretion of the instructor, students may not turn in coursework for evaluation after the last day of the scheduled final examination period unless they have received permission for a course Extension from the Registrar's Office. Course extensions are only granted for serious issues that arise "due to circumstances beyond the student's control."

### Appeal of Grade

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office

in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
