Course Description

A praxis-based introductory dance class open to all students. This course will focus on classical and contemporary dance technique. The training explores barre work, centre-practice and contemporary dance styles. Students will also be introduced to basic skeletal and muscle anatomy and health. Emphasis will be placed on exploring the rudiments of classical technique in addition to understanding rhythm, theme, and musical interpretation as it applies to choreography.

Expected Learning Outcomes

Students in TH 103 will be expected to demonstrate:

- 1. Understanding of physical anatomy, alignment, and freed breath as it pertains to dance.
- 2. The ability to execute and articulate all of the classical ballet positions of the Cecchetti style.
- 3. A diverse range of contemporary movement configurations set to rhythm patterns found in music.
- 4. The inclusion of personal expression within proscribed choreography.
- 5. Basic proficiency and application of learned skills in public performance.
- 6. Basic understanding of dance history and genres

All written assignments are to be handed in at the start of the class and are due in paper form.

Participation is marked out of 5 for every class with a late equaling an automatic 2.5 or lower and an absence a 0. In order to receive 5/5 students must arrive on time, fully prepared for class (in appropriate attire with all assignments ready), and demonstrate a willing and teachable attitude throughout class. Retention and advancement of skills, as well as engagement in the work will be factored into this daily mark.

Body Paper: a 3-5 page paper detailing the student's physical history, body usage, injuries successes and failures in movement as well as judgments, goals, and fears about their movement.

Quizzes: quizzes will be fill in the blank and short answer and focus on the anatomy section of class as well as handouts.

Reviews: students are required to attend two dance performances during this class. Along with attending the shows they will need to write a 2-3 page review on the performance based on criteria discussed in class and coinciding with technical understanding gained through classwork. Ticket stubs must be stapled to the paper.

Midterm: Students will be marked on a set piece of choreography and barre work for retention and execution of technique.

Final: Students will perform a piece of their own choreography (at least 1-2 minutes in length) plus pieces taught in class.

Attendance:

Attendance and punctuality are mandatory for all classes. There are no excused absences, and students are expected to be at class on time. On time means: in appropriate attire (leggings or athletic pants, and a t-shirt that allows full physical movement), prepared with required materials, and focused. To do this students will need to arrive at least 5 minutes earlier than the set class time. Students are permitted up to two absences per semester and are expected to make up all work missed. Upon a third absence, the student may receive a failing grade for the course at the instructor's discretion.

A late is considered half an absence.

Any lateness or absence will be reflected in the student's participation grade.

Grade Summary:

Communication

All students have received an Ambrose e-mail account upon registration. Registration

Exam Scheduling

Travel is not considered a valid excuse for re-scheduling or missing a final exam.

Appeal of Grade

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
