Course Description:

An introduction to aquatic ecosystem ecology with practical, hands-on training in the techniques used for the biomonitoring of aquatic macroinvertebrates. Instruction will consist of in-class completion of Canadian Aquatic Biomonitoring Network (CABIN) training modules at the level of Field Technician. This course includes a field practicum (approximately 16 hours) in aquatic bio-monitoring techniques that culminates in the student becoming a Certified CABIN Field Technician.

Expected Learning Outcomes:

Ambrose University Course Syllabus

- 1) Gain an introductory level of ecological theory relating to freshwater aquatic ecosystems.
- 2) Understand the current environmental challenges facing freshwater ecosystems in Alberta.
- 3) Connect theoretical concepts with practical field research methodologies and aquatic biomonitoring programs using aquatic macroinvertebrates as indicators of ecosystem health. For freshwater rivers and streams, benthic macroinvertebrates are the most commonly used indicators in biomonitoring programs.
- 4) Acquire the requisite skills associated with the CABIN training program culminating in CABIN certification at the level of Field Technician. The Canadian Aquatic Biomonitoring Network (CABIN) is the national biomonitoring program developed by Environment Canada that provides a standardized sampling protocol for assessing aquatic ecosystem health.
- 5) Participate in an applied field practicum using sampling techniques for aquatic macroinvertebrates.

Course Schedule:

May 02-04 (classroom), July 13-14 (field practicum)

Requirements:

Course evaluation is based on completion of training modules tests (section quizzes), one data entry assignment, and completion of field practicum. If students successfully achieve CABIN Field Technician Certification they will receive an "A" in the course. However, the performance on tests, assignments, and the practicum will affect their final percentage and letter grade.

Attendance:

Attendance at ALL components of the course are mandatory and cannot be made up if missed. Missing any part of the field practicum will result in an incomplete for the course.

Communication

All students have received an Ambrose e-mail account upon registration. Registration

During the **Registration Revision Period** students may enter a course without permission, change the designation of any class from credit to audit and /or voluntary withdraw from a course without financial or academic penalty or record. After that date, the original status remains and the student is responsible for related fees.

Students intending to withdraw from a course after the Registration Revision Period must apply to the Office of the Registrar by submitting a "Request to Withdraw from a Course" form or by sending an email to the Registrar's Office by the **Withdrawal Deadline**; please consult the List of Important Dates on the my.ambrose.edu website. Students will not receive a tuition refund for courses from which they withdraw after the Registration Revision period. A grade of "W" will appear on their transcript.

Exam Scheduling

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.

Students, who find a conflict in their exam schedule must submit a Revised Examination Request form to the Registrar's Office by the deadline date; please consult the List of Important Dates. Requests will be considered for the following reasons only: 1) the scheduled final examination slot conflicts with another exam; 2) the student has three final exams within three consecutive exam time blocks; 3) the scheduled final exam slot conflicts with an exam at another institution; 4) extenuating circumstances. Travel is not considered a valid excuse for re-scheduling or missing a final exam.

Appeal of Grade

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
