Course Description

This course will be a combination of lectures, directed study, and a practical component. It can be completed over one term or two. Lectures will include topics such as the physiology of sports injuries, injury prevention and rehabilitation, and training methods. Directed study will enhance these topics and include the most up-to-date research in these areas. Presentations or papers will be part of the course work.

This course will rely on independent work, in conjunction with a hands-on practical component which will include training methods and injury rehabilitation (eg. taping methods and rehabilitative exercises, etc.).

Expected Learning Outcomes

1. Students will gain a greater understanding of the anatomy and physiology of sports injuries
2. Student will learn the process of injury recovery and techniques to aid in the recovery process
3. Students will learn the fundamentals of sports medicine, taping, splinting, and physical therapy

This course consists of 2 hours of lectures per week, as well as out-of-class time in directed study. Students will also be required to complete observation hours and a practical component.

The midterm and final exam will be a combination of multiple choice questions, as well as short and long answer questions. While most questions will be based on lecture material, the textbook reading will absolutely help in the understanding of this material.

Attendance:

While attendance at lectures is not mandatory, it will help ensure success on course exams and assignments.

Attendance at practical labs is mandatory. There will be a combination of lecture material, independent directed study, a practicum (consisting of hours as a trainer and taping / splinting experience), as well as a term project.

Attendance at all lectures and tutorials are strongly recommended. This will help ensure success on lab assignments and exams.

Because of the nature of the Alpha 4.00 system, there can be no uniform University-wide conversion scale. Classroom Etiquette:

It is expected that students will take an active role in the learning process. This includes: (a) regular class attendance, (b) reading course material in advance of class, and (c) engaging in discussions during class.

In respect to the professor and to your fellow students, we ask that you:

Communication

All students have received an Ambrose e-mail account upon registration. Registration

During the **Registration Revision Period** students may enter a course without permission, change the designation of any class from credit to audit and /or voluntary withdraw from a course without financial or academic penalty or record. After that date, the original status remains and the student is responsible for related fees.

Students intending to withdraw from a course after the Registration Revision Period must apply to the Office of the Registrar by submitting a “Request to Withdraw from a Course” form or by sending an email to the Registrar’s Office by the **Withdrawal Deadline**; please consult the List of Important Dates on the my.ambrose.edu website. Students will not receive a tuition refund for courses from which they withdraw after the Registration Revision period. A grade of “W” will appear on their transcript.

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.

Exam Scheduling

Students, who find a conflict in their exam schedule must submit a Revised Examination Request form to the Registrar’s Office by the deadline date; please consult the List of Important Dates. Requests

will be considered for the following reasons only: 1) the scheduled final examination slot conflicts with another exam; 2) the student has three final exams within three consecutive exam time blocks; 3) the scheduled final exam slot conflicts with an exam at another institution; 4) extenuating circumstances. Travel is not considered a valid excuse for re-scheduling or missing a final exam.

Electronic Etiquette

Students are expected to treat their instructor, guest speakers, and fellow students with respect. It is disruptive to the learning goals of a course or seminar and disrespectful to fellow students and the instructor to use electronics for purposes unrelated to the course during a class session. Course extensions are only granted for serious issues that arise "due to circumstances beyond the student's control."

Appeal of Grade

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
