Course Description:

This course teaches systems of linear equations, Gaussian elimination, matrices, and vectors with elements and applications to coordinate geometry. It includes diagonalization and applications to Markov Chains and linear recursions.

Further Course Information:

The course consists of $2\frac{1}{2}$ hours of lecture and $1\frac{1}{4}$ hours of lab/tutorial per week. The course will include 5 quizzes, a Midterm, and a Final Exam. The quizzes will be written during the lab times. The best 4 out of 5 marks on quizzes will be taken in for grades.

Expected Learning Outcomes:

It is the aim of the course that students should

- 1. Understand and be able to utilize the Gaussian algorithm to solve many different problems relating to systems of linear equations.
- 2. Develop fluidity in matrix algebra and understand its relation to Markov Chains, linear recursions, and other mathematical models.
- 3. Be able to compute eigenvalues, eigenvectors, and diagonalized forms of matrices.
- 4. Be able to apply the concepts of linear algebra to the R³ vector space.

Policies:

All students have received an Ambrose e-mail account upon registration.
