## **Requirements:**

### 1. Attendance and Participation

Students are expected to attend each class session with an engaged frame of mind. Students should be prepared to contribute thoughtful conversation to the topics under discussion. Absence from class may result in a deduction of 1 mark. Class participation is assessed on the balance. Students whose attendance is perfect but who are otherwise unconversant with class material and discussion should anticipate a C+ (10.5/15) for this portion of their grade.

### **Policies:**

All students have received an Ambrose e-mail account upon registration. It is the student's responsibility to check this account regularly as the Ambrose email system will be the professor's instrument for notifying students of important matters (Cancelled class sessions, extensions, requested appointments, etc.) between class sessions. Travel is not considered a valid excuse for re-scheduling or missing a final exam.

#### **Electronic Etiquette**
