COURSE SYLLABUS

Course Description:

This course is an introduction to counseling theories and skills with particular emphasis on pastoral counseling in the Canadian Chinese Church context. This includes an introduction to theological and psychological foundations of pastoral counseling and to issues of integration. A major focus is on skill development. Secular and Christian approaches will be presented and critiqued with a view to implications for Christian counseling. Application will be made to problem management, opportunity development, and spiritual mentoring. This course is taught in Cantonese and English.

Course Objectives:

- 1. Understand and appropriate their vocation and identity in Christ, especially in their call to care for one another as followers of Christ (spiritual formation and ministry)
- 2. Achieve integration in the personal, theological, and ministerial dimensions of their lives, as care-givers (theological reflection on the practice of ministry)
- 3. Manifest godliness and exercise their God-given gifts, and abilities as under-shepherds
- 4. Provide godly nurture through pastoral counseling and spiritual mentoring

- 5. Serve and lead effectively in the caring ministry of the church, learning the basic skills of counseling
- 6. Interpret the Bible faithfully and relevantly according to a clearly articulated hermeneutic in the tradition of the Christian and Missionary Alliance
- 7. Reflect theologically from the perspective of an evangelical tradition that has been informed and enriched by the breath of the Christian tradition, especially in dealing with moral and ethical issues
- 8. Grow in their ability to bear witness to the Gospel and to lead the church in its mission, especially in the caring ministry of the church
- 9. Communicate effectively and relevantly the gospel especially in the Chinese context

Course Requirements:

1. Ministry Practice/Reflection components (10%): Each student would prepare a one page reflection of a recent counseling case he or she is familiar with and share it in class for discussion.

- 2. Formational Component (10%): Each student will prepare a one page discussion in note form on the spirituality of Jesus and how it relates to His ministry, and prepare to discuss this in small groups in class.
- 3. Book Report (30%): Each student will select one of the textbooks to write a book report of not more than 2,000 words, summarizing the contents and giving a personal reflection based on the book.
- 4. Final Paper (50%): Each student would submit an integrative paper on counseling a special group or a special need within the Chinese church, outlying the understanding of the problem from a psycho-social perspective, providing a Biblical understanding of the problem, and suggesting a counseling approach integrating Biblical and psychological perspectives. The paper topic must be approved by the instructor before the end of the course. The length of the paper should be between 5,000 to 6,000 words. The term paper format will be based on *A Manual for Writers of Term Papers, Theses and Dissertations*, by Kate L. Turabian (5th edition). The assignments including the book report can be completed in Chinese or English.
- 5. All assignment are due by July 19, and submitted by electronic means as an attached file to Dr. Simon Yiu Chuen Lee (<u>drsimonlee@cuhk.edu.hk</u>). Extensions are granted/approved only by the Registrar upon the recommendation of the professor if some serious or unforeseen circumstances arise. Students must provide before the end of the class a self-addressed envelope to receive back the marked assignments. Grading will be based on the standards set by Ambrose Seminary.
- 6. Attendance: Students are expected to attend all the classes and must ask for special permission to skip class.

Students may withdraw from this modular class and receive a full refund only prior to the first third of the class (i.e., before 9:00 am on **May 23, 2009**). No tuition refund will be issued after this deadline
