

# CC 645: Introduction to Pastoral Counseling Fall 2010

### **Course Description**

An introductory study of basic counselling skills and their application to personal problem solving in the local church context.

This course is focused on the student who is contemplating ministering in a professional pastoral or counseling role. Theories of counseling will be focused upon with the intention of integrating theology and psychology. Practical application of learned counseling skills will be implemented in class. Attention will also be paid to the ethical requirements regarding counseling in a pastoral or professional role, boundaries and proper protocol when providing pastoral care. Current issues that the majority of pastors and counselors face today will be explored and discussed.

If you have two exams at the same time, you will be given four hours to write both exams.

Graded final examinations will be available for supervised review at the Academic Office (L2044) and will be destroyed after six months.

# **Expected Learning Outcomes**

## With the successful completion of this course, you will be able to:

- Demonstrate the basic skills of counseling.
- Recognize your own belief system through introspection and how it affects the counseling process.
- Be aware of the dangers or pitfalls of the counseling process from a personal and ethical perspective.
- Summarize your own personal journey as you come to grips with the counseling process and how it relates to your beliefs of counseling, Biblical perspective and application of ministry.
- Support your position on the relationship between psychology and theology in the pastoral counseling process.

• Articulate different theories of counseling models (Christian and secular) and critique their strengths and weaknesses.

# **Course Requirements**

- 1. In-class involvement of the application of basic counseling skills. Teams will be formed and application of the counseling skills learned will be performed in class. Attendance will be taken during this part of the class schedule (weeks 5-8) as it will be taken into consideration for the final grade for this assignment. 20%
- 2. An interaction with the book entitled "Connecting" by Larry Crabb. This is not to be a book report or a summary of the book. You are to interact with Crabb's thoughts and ideas contained in the book. What do you think about what he is saying? Do you agree or disagree and why? (1000 words). **Due date: Oct. 15**th **10%** Please state how and where they hand this in.
- 3. A major paper will be required in this course. You are to write a 25-30 page paper or two 15-20 page papers on an issue that is relevant to pastoral counseling today. This paper is to be researched based using books, magazine articles, internet resources and professional journal articles. The idea is that you become an "expert" on the topic that you choose to write on. Examples of topics are: Pornography, divorce, depression, anxiety, stress, burn out, domestic violence, alcoholism, spiritual abuse, etc.
  - Please clear your topic with me before prior to starting the assignment. **Due date:** Nov 19<sup>rd</sup> 30% Please state how and where they hand this in.
- 4. The reading of the required course texts will count for **10%** of your final grade. Please state how, where, and when they hand in a statement saying that they read the texts.
- 5. There will be a Final exam the last on the last class of the semester worth 30%. Graded final examinations will be available for supervised review at the Academic Office (L2044) and will be destroyed after six months.
