#### **Course Description**

The course seeks to examine the theme of the 'desert/wilderness' experience in various traditions of Christian spirituality. An integrated biblical/historical/theological/formational approach to the subject will be adopted with a view to helping the student to understand the nature and purpose of the 'desert/ wilderness' experience in the spiritual life of the church and the individual. As a special feature, the course will also include a one-day guided silent retreat. (Class limit - 20 persons)

# **Course Objectives**

- expose the students to the prominence of the 'desert/wilderness' theme in the Old and New Testaments;
- provide the student with an historical/theological understanding of the major themes of 'desert spirituality' from the late third to mid-fifth centuries;
- inspire in the student a deeper appreciation for the formational value of certain spiritual disciplines which derive from the 'desert' tradition;
- offer guidance in the interpretation of and response to 'desert' experiences in the student's life journey

#### **Assignments & Grading**

- 1. A review/response paper (6-8 pages) based on Jeff Manion, <u>The Land Between</u> which incorporates the following:
  - a. a discussion of the significance of the book's title/subtitle as it pertains to the book's contents (5 marks);
  - b. a discussion of the development of the book's thesis (10 marks);
  - c. an identification of points of contact between the book's contents and the student's own spiritual journey (8 marks);
  - d. an assessment of the strengths, weaknesses and overall value of the book (7 marks).

(30 % of final grade)

- 2. A review/response paper (6-8 pages) based on Swan, <u>The Forgotten Desert Mothers</u>, which incorporates the following:
  - a. an explanation of the relationship between the title and the thesis/contents of the book (5 marks);
  - b. a discussion of the development of the book's thesis (10 marks);
  - c. an assessment of the book's strengths and weaknesses (10 marks);
  - d. an identification of 5 key issues raised by the book which require further study/analysis. Be precise. (5 marks)

# (30% of final grade)

- **3.** An autobiographical essay (6-8 pages) using Bernardin, <u>The Gift of Peace</u> as a prompter, on a personal 'desert experience' which does the following:
  - a. describes the circumstances whereby the experience entered your life (5 marks);
  - b. explains how the experience progressed in your life (5 marks);
  - c. reflects on the self-knowledge gained as a result of the experience (5 marks);
  - d. reflects on how your knowledge of God and your life were affected by the experience (5 marks).

(To be eligible for an 'A' range grade, your essay needs to make significant and specific references to the relevance of Bernardin for understanding your own 'desert experience'.

(20% of final grade)

- **4.** A **Reading Report** on two scholarly articles of the student's choice on the subject of desert spirituality which includes the following:
  - a. a summary of the thesis of each article;
  - b. a brief discussion of the main themes/ideas developed in each article;
  - an identification of at least 3 issues/subjects related to the content of each article which would require further research/consideration on your part.
     Note: each article can be reviewed in approximately two pages

# (10% of final grade)

**5.** A Reading Report (2-2 ½ pages) on 'The Life of Antony' in Wilson-Hartgrove, <u>The</u> Wisdom of the Desert Fathers and Mothers. (Paraclete/2010) which evaluates the

relevance/irrelevance of its contents for contemporary Christianity.

(10% of final grade)

#### **Important Notes:**

- A. Any student who is absent for more than one day of the course will not be eligible to receive a passing grade. All assignments must be completed and turned in to be eligible to receive a passing grade for the course.
