# **Course Description:**

This course gives consideration to the classical practice of spiritual direction in various Christian traditions from ancient to modern times and the influence of outstanding spiritual mentors in the 20<sup>th</sup> century.

Put succinctly, Christianity is about healing, and spiritual direction is a primary instrument for enabling it. The process is holistic, in which *spiritual* means the integrative formation of body, mind and heart.

Spiritual direction entails appreciation of the Holy Spirit's wildness, defying lines and margins, coming exceptionally, creatively, distinctively and uniquely to each person.

The rediscovery of spiritual direction as a central resource for the pilgrimage of each Christian brings with it the lament that few able spiritual directors exist with the contemporary church.

  - 3. Identify 3 issues which were raised for you by the book? Think 'within' and 'beyond' the book. (6 marks/11/2-2 pages)

4. What 4 subjects do you want to study further as a result of reading the book? (4 marks/3/4-1 page)

- B. A review/response paper (6-8 pages) on Kyriakos Markides, *The Mountain of Silence* which responds to the following questions :
  - 1. According to the contents of the book, what would be a working definition of the practice of spiritual direction? (Be as succinct and precise as possible!) (4 marks/3/4 page)
  - 2. What are the distinguishing characteristics of the spirituality of Father Maximos? What issues does it raise for you? (10 marks/2-3 pages)
  - 3. How would you characterize 'the style' of Father Maximos in his practice of spiritual direction? (Be specific with examples.) (8 marks/2 pages)
  - 4. How does the kind of spiritual direction described in the book fit with your experience of Christianity? (5 marks/1-1/1/2 pages)
  - 5. What is your overall evaluation of the book? (3marks/3/4 page)

- C. A reading report on 6 scholarly, peer reviewed articles of the student's choice on the subject of spiritual direction which includes the following for each article:
  - 1. A complete bibliographical citation;
  - 2. A summary of the thesis of each article; (1 mark)
  - 3. A brief discussion of the main themes/ideas developed in each article; (2 marks)
  - 4. An identification of at least 3 crtical issued which require further consideration/study on your part. (2 marks)

<u>NOTE</u>: if you are in doubt as to whether or not an article you have chosen is eligible for review consult with the professor for approval so as not to run the risk of having the article disqualified when being graded.

# **Policies:**

All students have received an Ambrose e-mail account upon registration.
