## **Course Description:**

This course is a multi-dimensional travel study experience designed to explore early Christian landscapes in Ethiopia.

Church buildings, perched on precipitous hilltops, or cut deep into the rock, offer some of the most dramatic sights in Ethiopia. Of great variety and often of impressive workmanship in comparison to surviving domestic architecture, they constitute an important part of Ethiopia's heritage today. The Ethiopian Orthodox Church that they represent is the most ancient institution surviving in the country...For visitors to the historical sites of Ethiopia, the churches and the ceremonies that surround them are among the most striking features of the highland northern and central Ethiopians' way of life.

The Church in Ethiopia, while having under [the] Apostolic Church of St. Mark the Evangelist in Alexandria, holds to also have an Apostolic foundation with the Apostle and Evangelist St. Matthew. There, he preached the teachings of Christ but he apparently arrived after the Ethiopian eunuch had been baptized. The story is based on the Abyssinian version of the Apocryphal Acts of the Apostles, attributed to a certain Abdia and apparently written in Arabic.

## **Important Dates:**

## **Expected Learning Outcomes:**

It is the aim of the course that the student acquires the following:

- 1. a knowledge of sites and landscapes germane to the study of early Ethiopian Christianity;
- 2. an appreciation of the dynamic interplay between the history, geography and spirituality in the development of early Ethiopian Christianity.

## **Outline:**

The student will receive a detailed daily itinerary of the sites to be visited from Jan. 13-28/2016

# **Requirements:**

#### A. a research paper (40% of the final grade)

A research paper (approximately 12-15 pages) not including bibliography, which does the following:

- 1. investigates a subject pertinent to the travel study course itinerary <u>in consultation with the professor</u> (please submit an outline of your paper with supportive bibliography before you begin to write);
- 2. develops a thesis in response to a critical question raised by the paper;
- 3. follows an acceptable form of scholarly documentation;
- 4. includes a comprehensive bibliography with a minimum of 20 entries consisting of books (or monographs) and scholarly, journal articles.

#### B. a guided book review (6-8 pages) (30% of the final grade)

A guided book review (approximately 6-8 pages) of Graham Hancock, *The Sign and the Seal*.which includes the following:

1. a brief summary of the thesis of the book which shows the relationship between the book's title/subtitle

and the thesis; (3/4-1 page/5 marks);

- 2. a discussion of the development of the thesis; (2-3 pages/10 marks);
- 3. a critical analysis of 3 strengths and 2 weaknesses of the book with specific references to book's content to support your arguments. (2-3 pages/10 marks);
- 4. an overall evaluation of the book including what was most of interest to you and why; (3/4-1 page/5 marks).

#### C. an evaluation paper (30% of the final grade)

An evaluation paper (6-8 pages) which includes the following:

- 1. a description of 3 of your most profound 'epiphany' moments with an assessment of how each of them has affected your perspective relative to the subject; (2-3 pages/10 marks)
- 2. an identification of 3 of your most interesting learning experiences with an outline of further new areas of study suggested by what you learned; (2-3pages/10 marks)
- 3. an overall assessment of the personal value of *Magnificent Ethiopia*... as an educational experience. How did it contribute to your understanding early Christianity. What do you want to study further as a result of this travel study experience? (2-3 pages/10 marks)

## **Policies:**

All students have received an Ambrose e-mail account upon registration.
