

Field Experience 700 Seminar INTRODUCTION TO THE LIFE OF CURRICULUM DESIGN AND PROGRAM DEVELOPMENT (Fall 2011)

Course Description

The Field Experience Seminar is a non-credit class intended to deepen and broaden the student's understanding of the interconnectedness of curriculum design and program development in Alberta's public school classrooms with learners, teachers and society. This seminar is designed to prepare students for success in the Field Experience 700. The goal of the seminar is for students to reconsider and reframe their assumptions, theories, values and concepts regarding curriculum and programs designed for use in Alberta's public school classrooms. The seminar uses the shared praxis methodology of guided reflection on previous teaching experiences informed by research and best practices. The following topics will be considered: assessment and evaluation in Alberta schools; parental engagement; educational technologies; teacher vision and teaching philosophy; and, ministry approaches to achieving excellence in educational practices (ie. teaching quality standards and certification of teachers).

Course Requirements

This course requires your participation in four ways:

1. Preparation

Please check the Moodle site at the beginning of each week (Monday) for instructions about how to prepare for the upcoming seminar. This may include reading an article or viewing some media, reflecting on a question that has been posed, or bringing something to class.

2. Contribution

During the seminar, it is expected that students will engage in exploratory dialogue, reference theory and research, and offer examples from experience. Students should feel free to initiate new ideas and 'think aloud'.

3. Critical Reflection

Students are expected to examine their own position without defensiveness. Students are invited to reflect on the gaps that exist between theory and practice, and also their assumptions and reality.

4. Active listening

Students should respect one another by listening carefully, taking note of detail, clarifying and paraphrasing others' perspectives, and building on each other's points.

Important Notes/Dates:

The last day to enter a course without permission and /or voluntary withdrawal from a course without financial penalty (**drop**) – Sunday, September 18, 2011 (Fall semester) or Sunday, January 22, 2012 (winter semester). These courses will not appear on the student's transcript. Courses should be added or dropped on the student portal by the deadline date.

Students may change the designation of any class from credit to audit, or drop out of the "audit" up to the "drop" date indicated above. After that date, the original status remains and the student is responsible for related fees. Please note that this is a **new policy**, beginning in the 2010-2011 academic year.

Withdrawal from courses after the Registration Revision period will not be eligible for tuition refund. The last day to voluntarily withdraw from a course without academic penalty (*withdraw*) – Monday, November 14, 2011 (Fall semester) or Friday, March 23, 2012 (Winter semester). A grade of "W" will appear on the student's transcript.

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.
