**Course Description:** An introduction to the four seminary program outcomes which identify the areas of personal growth expected of students during seminary education. The course assignments for this one credit requirement are completed independently for discussion with an academic advisor.

This course is evaluated as a pass-fail course using the standard rubric.

**Expected Learning Outcomes:** Upon successful completion of this course, the student will

- understand the four seminary program outcomes (2019-20 Academic Calendar, page 10).
- reflect on the current state of their theological knowledge, their communion with God and love of neighbour, their understanding of their place of service in the world, and their capacity to engage in God's work in the world as they begin their seminary education.
- identify resources for personal growth in these four areas.

**Course Schedule:** This course is an independent study that requires at least two meetings with an academic advisor, one to plan the process and a second one to assess the essays. The course should be completed after 15 credits of a MA IM, MA LM, MCS or MDiv program are finished.

# **Requirements**:

- 1. To meet with the academic advisor to plan the process.
- 2. To Read the letter on the seminary program outcomes.
- 3. To read the reading resources.
- 4. To prepare four reflective essays, one on each of the program outcomes, articulating how they understand the outcome, what areas of growth they anticipate during their seminary education, and what resources might be helpful to facilitate this growth. Maximum length of each essay: 4 pages (1200 words)
- 5. To collect the documents as indicated in the current PGP Student Handbook.
- 6. To complete the PGP Summary Rubric and Waiver (2021) for program assessment; submit this form to the academic advisor.
- 7. To meet to discuss the essays with the academic advisor.

Assignments due date: July 25<sup>th</sup>, 2023

Grade Summary: this course is graded pass-fail.

## Communication

All students have received an Ambrose e-mail account upon registration. Students intending to withdraw from a course after the Registration Revision Period must apply to the Office of the Registrar by submitting

a "Request to Withdraw from a Course" form or by sending an email to the Registrar's Office by the **Withdrawal Deadline**; please consult the List of Important Dates on the my.ambrose.edu website. Students will not receive a tuition refund for courses from which they withdraw after the Registration Revision period. A grade of "W" will appear on their transcript.

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.

## Exam Scheduling

Students, who find a conflict in their exam schedule must submit a Revised Examination Request form to the Registrar's Office by the deadline date; please consult the List of Important Dates. Requests will be considered for the following reasons only: 1) the scheduled final examination slot conflicts with another exam; 2) the student has three final exams within three consecutive exam time blocks; 3) the

Course extensions are only granted for serious issues that arise "due to circumstances beyond the student's control."

#### **Appeal of Grade**

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
