Course Description:

This seminar-oriented course is designed to interact on current theological, anthropological, historical and methodological themes that have a bearing on contemporary missions. The course combines individual research, faculty-student dialogue, and an integration of subject material from various course offerings. The diversity of understanding of the church's worldwide mission as expounded in various traditions will be explored. Prerequisite: MI 502

This course is a directed study so the syllabus has been crafted by the student in consultation with the professor in order to tailor the course to the student's needs. This process also allows consideration of the student's past experience and and background in evangelism and discipleship.

Ambrose University Course Syllabus

Expected Learning Outcomes:

1) Develop a greater knowledge and understanding of 4 current trends and issues in missions (orality, spiritual warfare, ministering in the context of worldview differences, and Islam and Christianity.)

2) The student will experience communicating using orality principles.

3) The student will gain an appreciation for the role of intercessory prayer in spiritual warfare.

4) The student will develop an empathy for those who operate from a different worldview perspective.

5) The student will develop a greater compassion for Muslims and a greater willingness to engage with them.

Requirements and Evaluation:

- All assignments are **due by midnight on the specified date**. Assignments should be submitted in **digital format** as an attachment to an email.
- The student is expected to meet at least monthly with the professor to discuss the course content and her progress on the learning activities.
- **Extensions** may be granted on written assignments in exceptional circumstances, but must be arranged in advance. The **late penalty** is one refined letter grade per class day late. Moreover, late assignments will be graded and returned later than on-time submissions.
- All assignments must be submitted to receive a passing final grade.

Participation - 10%

Participation is based on the visible engagement with and understanding of the material under consideration. The student will meet with the professor at least 5 times during this course. Two of these times will be in a forum format with another student and the professors. Times and themes for these encounters are listed in the chart that follows. The student will submit questions for each session at least one day in advance of the appointment and will confirm the appointment with the professor. Instructions for preparation for the forums will be presented to the students prior to the forum.

Trends and Issues Paper 10% DUE: September 22, 2017

The student examine several current trends and issues in missions and to enable you to choose 4 of these on which she desires to focus this semester. The assignment should be 5-7 pages long, double spaced in a 12 pt. font. Sources whether written or oral need to be included. She should explore at least 5 or 6 different sources for this assignment. (Whether people or books.) This assignment is worth 10% of the final grade. This project will be evaluated on the basis of the criteria discussed with the student and follow the major paper/project rubric presented to the student.

Syllabus Development Exercise 10% DUE: September 22, 2017

This exercise will be graded on the basis of the quality of the submitted syllabus preparation guide. Criteria will include how thoroughly the student responded to the questions asked in the guide, the quality of learning learning outcomes, learning strategies and evaluation procedures. The finished paper should be at least 4-6 pages in length. The student will also be expected to have made the amendments suggested during her interview with the professor prior to submission of the assignment.

Review and Reflection on Beilby's book (spiritual warfare) 12% DUE: October 26, 2017

The student will write a 4-6 page critical review of this **text**. She will briefly explain the four views of spiritual warfare, critique these views from a biblical and theological perspective and describe how this book shaped her understanding of this topic. Evaluation will be based on the book critique rubric and criteria discussed with the student.

Review and reflection on Muller's and Georges Books 12% DUE: November 16, 2017

The student will write a 4-6 page critical review of these texts. She will describe the three main worldview perspectives presented in these books, and then she will discuss how these perspectives might influence our efforts to present the Gospel in each context. Evaluation will be based on the book critique rubric discussed with the student.

Review and reflection on Trousdale and McCroskey's Books 12% DUE: November 30,2017

The student will write a 4-6 page critical review of this text. She will describe what she has learned about Islam and how to present the Christian faith in a Muslim context. Evaluation will be based on the book critique rubric discussed with the student.

Orality and Biblical Storytelling 34% DUE: Dec. 12, 2017

The student will read Kohler's book, and then using the orality method will learn at least two Bible stories and will tell them in a group setting. She will also tell the same stories to her professors. She will then write a 5-7 page paper about this experience. In this paper she will summarize the historical development of the strategy, where it is currently being used (context), the impact this sterategy is having in oral cultures. She will explore the strengths and weaknesses of this strategy and her evaluation of its usefulness in missions. This project will be evaluated on the basis of her grasp of orality concepts and principles and according to the criteria discussed with the student It will follow the major paper/project rubric discussed with the student.

Further directions and clarification for these assignments may be given in consultation with the professor before they are due.
