Course Description:

This three-hour, hands-on, online workshop will give you the theological and homiletic tools for unpacking and preaching God's revelation through creation (alongside and through the scriptures).

Expected Learning Outcomes:

- 1. Students will be better equipped to engage and preach God's revelation through physical world God has made. They will come to understand and encounter Jesus as *not just* as the mediator of salvation but also the mediator of creation.
- 2. Students will learn how to (with the help of science-related professionals) exegete creation texts. They'll be given the tools to come alongside scientists and theologically converse with, and guide them, them in the process of unpacking creation texts.
- 3. Students will learn how to craft and preach a co-illumining 'two-book' sermon (based on the creation and biblical texts).

Course Schedule:

March 24, 2021 – A three-hour workshop on how to preach creation texts

Requirements:

Students will be required to write and preach one science/creation-based sermon. Sermon manuscript will be submitted for grading/feedback before it is preached. Sermon video will also be submitted for final grading.

Students will also submit a 300-word book report on Kuyper's Wisdom and Wonder.

Exam Scheduling

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.
