### Course Description:

This course will be an examination of the theology, posture, and practices of the early and continuing C&MA (in general and, specifically, in the Canadian prairies) to discover what, if anything, makes it particularly suitable for the development of ecumenical church-planting work in small, rural settings on the Canadian prairies, particularly, the current Canadian Mid-West District of The Christian and Missionary Alliance in Canada.

### Requirements:

**1. Annotated Bibliography (35%)**

The student will develop an annotated bibliography of sources, of various types (this may include books, magazine and journal articles, newspaper stories, denominational and local church board minutes, etc.), that speak to the question at hand. In addition to providing the bibliographic information on sources, the assignment calls on the student to provide a summary of each source and assess value and/or relevance of each. This evaluation should consider the value of the sources, both to the task at hand and to C&MA research more generally. The grade for this assignment will consider the number and breadth of sources consulted and the quality of the written work provided. Rather than being prematurely selective, the student should be liberal in the variety of sources consulted and examined. The student should be sure to consult regularly with the professor regarding the variety and breadth of the sources being consulted.

**2. Research Paper (65%)**

The student will prepare a paper (a minimum of 25 pages) that assimilates and synthesizes the findings gleaned from the bibliographic work. This paper will be sure to be descriptive, analytical, and, should the findings and the desires of the student warrant, prescriptive. The paper should focus its attention to the question, "What, if anything, in the Alliance "DNA" would suggest it is well-suited to build ecumenical community spiritual care in sparsely populated regions?"

Among its other tasks, this paper should seek early to define what it means by the polyvalent terms "ecumenical" and "spiritual care." In addition, it should also be sure to note, if not explore, those innate or acquired characteristics of the C&MA that may also confound this same project.

## Policies:

### Communication

All students have received an Ambrose e-mail account upon registration. ### Registration
