Course Description

本科繼西方教會史而開的延續課程·涵括亞洲各區的教會·除簡介 1500 年以前的西亞教會概況作為導論外·本 科主要探討 19 世紀以後由印度向東直至日本等地區的基督教發展。本科亦附加美國教會近 300 年歷史。

This is a continuous course following the Western Church History. It is mainly dealt with the contemporary Asia Church history. As an introductory information, we will first touch the West Asian church history before 1500 A.D. The course will focus on the 19th and 20th century in South and East Asian Countries from India to Japan.

This course also cover outlined American Church History as foundational knowledge for pastors to serve God locally. 内容提要:本科主要介紹中東、印度、中南半島、馬來西亞、印尼、菲律賓、日本、韓國、台灣及香港等地的教 會發展。課程以宣教角度及本色神學反省為主,探討基督教發展的掙扎,亦介紹當地文化、政治、宗教及社會的 近況,以配合基督教在當地的見證。

This is an overview of the origins, history, and recent development of the Christian activities of the following countries: Middle East, India, Burma, Thailand, Vietnam, Malaysia, Indonesia, Philippines, Japan, Korea, Taiwan and Hong Kong. We will focus on the political, cultural, religious and social situation of the mentioned countries. We also take the perspectives from mission and explore the meaning of contextualization.

Expected Learning Outcomes

Student should understand different cultural issues and respect the missionary effort in cross cultural ministry. They also would learn basic knowledge of various religious and philosophical thought in Asian countries. As a Christian in Canada, we also know about American church history as our foundation knowledge which will help us more effectively to serve God locally.
