# **Course Description**

This course endeavours to survey women's writing in the English language from the Middle Ages to the end of the twentieth century. The material will be read through the eyes of feminist literary theories, focusing especially on the recent decades of scholarly activity.

## **Course Objectives**

- 1. This course will introduce students to the major and hithertooverlooked female authors and the feminist theoretical arguments which have shaped the interpretation of literature.
- 2. This course will give students an understanding of the various genres of women's writing and the many voices within feminist theory.
