II. RELEVANCE AND DESCRIPTION OF THE COURSE:

An expository study of the Gospel of Matthew and an exploration of the literary, argumentative, historical context and theological content of the Gospel. Special attention is given to Matthew's theology of Christ, to Matthew's common and distinctive theological features, to the parables, and to the various methods employed in the study of Matthew.

Students will be encouraged to read Matthew carefully, interpret it contextually, and engage with this well-known Christian masterpiece both critically and personally, thereby hearing anew the gravity of the teachings of the Matthewan Jesus and reconsidering what it may mean to follow him today.



III. LEARNING OBJECTIVES:

Objectives (cognitive and procedural):

At the end of this course students will be able to:

General objectives.

- 1. Describe the content of the Gospel of Matthew in terms of its structure, themes and typologies.
- 2. Articulate the emphases of the Gospel of Matthew with reference to its background historical and social.
- 3. Explain the composition of the Gospel of Matthew with respect to the synoptic problem.
- 4. Identify the distinctive voice of the Gospel of Matthew among the other gospels canonical.
- 5. Evaluate the theological contributions of the Gospel of Matthew to the NT canon, in terms of theological concepts such as Christology, soteriology, ecclesiology, and themes such as messianism, Torah observance, the use of the Hebrew Scriptures (intertextuality), relations between Jews and Gentiles (mission), discipleship and ethics.
- 6. Acquire knowledge about the countless approaches to interpreting and contextualizing the Gospel of Matthew.

IV. CONTENTS:

The course will be taught with prior readings, prior work, four days in person and subsequent work.

Orientation meeting and introduction to the course, on August 29 at 11:00 a.m. via Zoom.

Previous readings:

The Gospel of Matthew from an updated version such as The Bible of the Americas, The Updated Reina Valera, etc. (The NIV is a dynamic translation that does not represent the Greek text well.)

There are other required and suggested prior readings according to the agenda that follows.

Teacher's notes.

During the face-to-face classroom:

September 25: Introduction; Matthew 1–7

September 26: Matthew 8–13



September 27: Matthew 14-18

September 28: Matthew 19-28

Previous jobs:

A theological work on an important topic or interest within Matthew.

Theological project (10-20 pages with 5 scholarly sources): Each student will write a theological project on a theological topic of importance in Matthew. You must define a very specific question regarding the message of the text.

Examples: Does Matthew teach that the church replaces Israel? What does Matthew teach regarding the application of the law of Moses in the church? Is the kingdom equivalent to the church in Matthew? What is necessary to do to be saved in Matthew?

It is important at the beginning of the course that you submit a written proposal of your topic to receive further guidance.

Later works:

An exposition of a chapter from Matthew.

Expository Project (10-20 pages with 5 scholarly sources): Each student will write an expository project on a chapter of Matthew according to seminary standards. It is expected that there will be a good distribution of the chapters among the students.

For this reason, each student will submit their first and second choice according to their own priority to distribute the chapters among everyone, on the first day of the in-person course.

To observe the growth and development of the student in this course, the following indicators of class achievements (specific objectives) will be taken as reference:

1. Reading report of the entire Gospel of Matthew in Spanish before in-person classes and reading the teacher's notes. The report will affirm the reading and include key questions regarding personal concerns regarding possible interpretations of key Gospel passages within the text and teacher's notes (3 to 5 pages). twenty%

SAW. METHODOLOGICAL STRATEGY:

This course will be developed through the *active learning methodology*, using mostly strategies such as peer learning, team based *learning*, and *the Flipped Classroom*, which allows student engagement. with its teaching-learning process. Along with synchronous classes (virtual and/or in-person), content delivery will be addressed through self-instruction. This course will last 7 weeks, the last of which will be for the delivery of the final project.

The course has a prior reading of the teacher's notes (and other required ones) and the Bible with a report that requires a "critical" reading of the possible interpretations of the most important passages and theology in terms of understanding the author's first communication and their audience and then apply the text in the student's context.

Additionally, each student has to write a previous project about a topic of importance within Mateo.

Student participation within the face-to-face classroom is required in terms of their questions and contributions. In the end, academic research is expected in the use of good academic sources regarding the exposition of a chapter of Matthew.
