# **Course Description**

In this course we explore the life, ministry, and theology of Paul, based on a paragraph by paragraph exposition of 1 and 2 Corinthians in their literary, argumentative, and historical contexts. Attention will be given to practical concerns of application and hermeneutical issues raised in applying these two letters in the modern world today.

Prerequisite: NT 501 New Testament Foundations (or equivalent)

## **Course Objectives**

At the successful completion of this course, each student is expected to have achieved competence in the following areas:

- 1 ability to exegete passages from 1-2 Corinthians according to a clearly articulated hermeneutic
- 2 understanding of:

- the reasons why Paul wrote each letter
- the major theological ideas found in each letter
- the argumentative structure of each letter
- the historical background of each letter
- 3 capacity to reflect theologically upon Paul's teaching on spiritual gifts as it comes to expression in the two letters
- 4 employ principles of Pauline Theology in the solving of problems faced in the Christian life and world today
- 5 comprehension of Paul's theology of mission and ministry as it came to expression in his life and how this may impact the student's spiritual formation and sense of vocation and identity in Christ

### Course Requirements

Students are required to do four assignments, based on four choices below. Students should spend about 25 hours on each assignment.

By the end of the week of classes, students must inform the professor in writing of what their choice of requirements. Each requirement will be due on the following dates:

Requirement #2:	Monday, June 26
Requirement #3:	Monday, July 17
Requirement #4:	Monday, August 7

#### (1) Philosophy of Ministry Paper (25%)

Students are to write an eight-page paper exploring Paul's theology of ministry and leadership as it comes to expression in 1-2 Corinthians (you cannot go outside these two letters), and reflect on its potential application in ministry today. Students may write a sixteen-page paper and have it count for two requirements. A number of questions could be asked:

- What is the basis of Paul's authority?
- What do you perceive to be Paul's strengths and weaknesses as a leader?
- How is Jesus Christ a model of ministry and leadership for Paul?
- How does Paul share his leadership and authority with others?
- How does Paul defend his ministry in the face of charges against him?
- What are some valuable lessons that you have learned from your study of Paul's theology of ministry and leadership?
- What place, if it all, do spiritual gifts have in Paul's theology of ministry?
- What principles can we learn about leadership from 1 Corinthians 3.5-4.21 or from 2 Corinthians 2.14-7.4?

(2) Exegetical and/or Thematic Papers (25%)

Using guidelines distributed in class, students may write eight-page exegetical or thematic papers on passages or topics of their choice from 1 or 2 Corinthians.

(3) Sermon or Bible Studies series (25%)

Students will exegete a topic or passage from 1-2 Corinthians (different from the other assignments) and prepare and deliver in a church a sermon based on that exegesis; or prepare and deliver at least two Bible studies based on their exegesis. Students should submit their rough exegesis, a manuscript of their sermon or preferably a video/audio of it. For the Bible studies, submit the rough exegesis, an outline or manuscript of the Bible studies and a very brief reflection (max. 200 words) on how the Bible studies went.

(4) Commentary Book Review (25%)

Read 300 pages from one or both commentaries. Begin by reading a passage in 1 or 2 Corinthians and generate a list of questions to which you would like an answer ("Step five" of "Fifteen Steps"). Then read the corresponding pages in the commentary of answers to your questions. Write a six-page (max.) report (can be in point-form). You might write it in a question-and-answer format.
