Course Description

This course helps the student develop a rule of life that fits their personality, season of life, and unique situation. It explores the nature and goal of spiritual formation, as well examines our rich inheritance of spiritual practices from Scripture and church history. The student will also be asked to undertake an intensive study of one biblical or historical figure in light of that individual's spiritual formation (and, if warranted, deformation). Overall, the emphasis will be on the student cultivating increasing Christ-likeness expressed through their God-given personality.

Note: An additional fee for MBTI testing will apply. See Financial Information section for details.

Expected Learning Outcomes

At the end of this course, the students will be able:

1. To identify current literature, trends, and movements in the field of spiritual formation, renewal and direction. 2. Comprehend traditional spiritual discipline in church history. 3. To ascertain how to cultivate and enhance heart intimacy with God. 4. To appraise the value of classical spiritual disciplines such as simplicity, solitude, fasting, biblical meditation, contemplation, and journaling for deepening one's relationship with God. 5. To understand the dynamics of and acquire modest competence in the art of spiritual direction. 6. To construct a viable model that integrates theology, spiritual disciplines, and care-giving to the total person.

Requirements:

- 1. Read any two textbooks and write two three-page reading report. (20%)
- 2. Develop a Rule of Life. (20%) Using class materials and required readings, develop a Rule of Life – a plan of your personal growth, the spiritually formative disciplines that keyed to your personality, calling, season of life, weak areas of life, and discuss each practice, why it is important to you, and your plan to implement it.
- 3. Explore a single classical spiritual practice (i.e., fasting, solitude, Scripture meditation, alms giving, etc.) and give a brief account of its biblical foundation and its history within the church, as well as discuss its benefits, possible drawbacks, and

- your own practice or intended engagement with this discipline, with some reflection on how it might benefit you in your calling. 5-6 pages. (30%)
- 4. At the end of the course, the student is required to reflect upon and evaluate the course. This will be done in answering the questions below in writing. The evaluation shall be of 1000-1500 words. (30%)

A. Knowledge:

What new knowledge have I learned cognitively? In what ways will I be able to apply this in the context of my ministry? How is this knowledge relevant to the members of my church?

B. Skills:

Did the course prepare me for the ministry (ordained or otherwise), or anyone seeking to be accepted for training? In what ways did it help me and in what ways did it fall short from its goal and intent? Which views and perspectives of mine have been challenged or changed as the result of this course? As someone put into a position of spiritual authority, how do I instill insights flowing from my study of Personal Formation and Development into my church?

C. Spirituality/Character Formation:

What new Christian attitudes have been formed (or are in the process of being formed) due to an awareness, new knowledge on the church fathers' or the reformers' spiritual formation? In what ways have I become a better Christian as the result of this course?

Submission of Assignments:

The reports and the reflection paper should be submitted to the instructor on or before Dec 25, 2019 through e-mail. Name, email address and course title should be put on the paper. Self-evaluation (1-10 %) must put on the first page of research paper.

Attendance:

Although attendance makes up no portion of your grade, you are expected to fully participate in class discussions and to integrate the course material into your written work. Therefore, make every effort to attend and fully participate in each three-week module classes. It is extremely important that you attend 100% of the class time.

Ambrose University Academic Policies:

Communication

All students have received an Ambrose e-mail account upon registration. It is the student's responsibility to check this account regularly as the Ambrose email system will be the professor's instrument for notifying students of important matters (cancelled class sessions, extensions, requested appointments, etc.) between class sessions. Registration

During the **Registration Revision Period** students may enter a course without permission, change the designation of any class from credit to audit and /or voluntary withdraw from a course without financial or academic penalty or record. Courses should be added or dropped on the student portal by the deadline date; please consult the List of Important Dates. After that date, the original status remains and the student is responsible for related fees.

Students intending to withdraw from a course after the Registration Revision Period must apply to the Office of the Registrar by submitting a "Request to Withdraw from a Course" form or by sending an email to the Registrar's Office by the **Withdrawal Deadline**; please consult the List of Important Dates on the my.ambrose.edu website. Students will not receive a tuition refund for courses from which they withdraw after the Registration Revision period. A grade of "W" will appear on their transcript.

Students wishing to withdraw from a course, but who fail to do so by the applicable date, will receive the grade earned in accordance with the course syllabus. A student obliged to withdraw from a course after the Withdrawal Deadline because of health or other reasons may apply to the Registrar for special consideration.

Exam Scheduling

Students, who find a conflict in their exam schedule must submit a Revised Examination Request form to the Registrar's Office by the deadline date; please consult the List of Important Dates. Requests will be considered for the following reasons only: 1) the scheduled final examination slot conflicts with another exam; 2) the student has three final exams within three consecutive exam time blocks; 3) the scheduled final exam slot conflicts with an exam at another institution; 4) extenuating circumstances. Travel is not considered a valid excuse for re-scheduling or missing a final exam.

Course extensions are only granted for serious issues that arise "due to circumstances beyond the student's control."

Appeal of Grade

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
