

# Conflict Management in the North American Chinese Church (PT530-CM)

北美華人教會衝突管理

## **Course Description:**

The purpose of the course is to help Chinese-speaking Christian leader to establish a basic understanding of conflict and conflict management in their church ministry. This course includes a basic understanding of conflict, a biblical view of conflict, and an analysis of each participant's personal conflict management style. Chinese concept of "great harmony" and "great honour" are introduced and relational pattern of thinking reviewed. The effect of multiculturalism in the Canadian Chinese churches is examined. Guidelines for leaders to prepare themselves to be competent conflict managers are also presented. This course is taught in Cantonese.

#### Instructor:

Dr. Titus Yu (DMin) brings years of Canadian Chinese church ministry and experience in the engineering environment to the study of conflict management. BA in Mechanical Engineering, Certificate in Biblical Studies (PBI), MDiv (CTS), DMin (CTS). Dr. Yu has been serving in Edmonton and Richmond since 1985 till now as a Canadian C&MA pastor. Currently Dr. Yu serves as the Senior Pastor of North Richmond Alliance Church, and a member of Canadian Chinese Alliance Churches Association Executive Committee. Editor of the sermon collections

of Canadian Chinese Alliance churches《靈語澤》and the Alliance Communique《宣訊》.

#### **Course Learning Outcomes:**

- 1. Understand the issues of conflict management in a postmodern era.
- 2. Learn using biblical guidelines to resolve conflicts in a Canadian Chinese church under a bicultural setting.
- 3. Develop an understanding of one's personal conflict management style and be able to respond to the conflict situations.
- 4. Learn to engage conflict events productively and serve competently as a pastor/leader in ministry.
- 5. Learn to implement an effective conflict ministry team for the local church.
- 6. Understand the conflict management policy and approach of the Chinese churches within the C&MA in Canada.

## **Course Requirements:**

- 1. Class Room Attendance & Participation Each missed class will lower one grade of the final mark (for example: "B+"  $\rightarrow$  "B").
- 2. Required Reading Read 1,000 pages from the required textbook and other recommended readings.
- 3. Five full written text Biblical case studies, each 3 pages in Chinese.
- 4. One project in the ministry. Use the class material to design a two-session workshop. Gather information and analyze a people group. (Detail will be discussed during the classes) Could be substituted by research paper.
- 5. One short reflection paper (5 pages) to reflect on your understanding of the Conflicts Management in Chinese Church today.

#### **Evaluation:**

- 1. Classroom attendance & participation 10%
- 2. Readings and report (book titles and page number) 10%
- 3. Five Biblical case studies (3 pages each) 25%
- 4. Project in ministry 45%
- 5. Reflection paper (3-5 pages) 10%

#### **Assignment Due Dates:**

- 1. Reading and report are due on Feb. 19, 2009 during class.
- 2. Biblical case studies are due on Feb. 21, 2009 during class.
- 3. Assignments may be submitted in either English or Chinese.
- 4. Course project write-up & the personal reflection paper must be mailed to the instructor prior to the due date of April 4, 2009.

## Registration
