Course Description:

Worship is an opportunity for Christians to communicate with their Creator. It is primarily a relationship of the creature and the Creator in which reverential awe is expressed in a variety of ways. The development of a meaningful worship in a given setting rests largely on one's awareness of the theology, history, and dynamics of the worship experience.

This course provides student the opportunity to understand the biblical and theological foundations of worship. The student in this class will emerge with a clearer understanding of the history of worship, the relationship of worship to music and other areas of personal life and local church ministry. Attention will be given to both theory and practice of worship.

Expected Learning Outcomes:

As a result of taking this course, the student will be able to:

- 1. Understand who is God, and what is expected by Him from His worshippers.
- 2. Comprehend the Biblical and Theological Foundation of Worship.
- 3. Understand the importance of worship in life and ministry
- 4. Develop a personal philosophy of worship and apply it in ministry.
- 5. Understand the purpose of worship service and who is it for.
- 6. Understand the relationship between worship and music.
- 7. Articulate and defend his or her theology and philosophy of worship, based on his or her understanding of relevant biblical data, historical development and practice.
- 8. Design and lead a congregation or group in biblical, meaningful corporate worship.

- b. Read another 800 pages from the recommended text books. Submit a reading log of the books and number of pages read. (10%)
- 2. Participate in a group project to plan, prepare, and lead a corporate worship service within the course time period. (10%)
- 3. Participate and observe one service in a local church of a different denomination from your own, and write a two-page review regarding its theology and practices of worship. (10%)
- 4. Write a paper (15 pages) with footnotes and bibliographies based on one of the following topics. (40%)

Assignments & Due Dates

- 1. The two reading reports will be submitted on March 11, 2017. The personal reflection paper, course paper, worship review, and the reading assignments will be submitted on May 11, 2017. Assignments may be submitted in either English or Chinese.
- 2. Grade point will be penalized for any late assignment.

Policies:

Communication

All students have received an Ambrose e-mail account upon registration. Registration

Students will not receive a tuition refund for courses from which they withdraw. A grade of "W" will appear on their transcript.

Appeal of Grade

An appeal for change of grade on any course work must be made to the course instructor within one week of receiving notification of the grade. An appeal for change of final grade must be submitted to the Registrar's Office in writing and providing the basis for appeal within 30 days of receiving notification of the final grade, providing the basis for appeal. A review fee of \$50.00 must accompany the appeal. If the appeal is sustained, the fee will be refunded.
